



Agreement between the European Society of Anaesthesiology and Intensive Care (ESAIC) and the Sociedade Brasileira de Anestesiología (SBA)

1) This document stands as an official agreement between

EUROPEAN SOCIETY OF ANAESTHESIOLOGY AND INTENSIVE CARE AISBL, International non-profit organisation incorporated under the laws of Belgium, having its registered offices at rue des Comédiens 24, 1000 Brussels, Belgium, registered under company number 0447.289.368, represented by Prof. Wolfgang Buhre, President of the Board of Directors, duly authorised,

hereinafter referred to as "ESAIC", and

SOCIEDADE BRASILEIRA DE ANESTESIOLOGIA, a non-profit organisation incorporated under the laws of Brazil having its registered office at R. Prof. Alfredo Gomes, 36 - Botafogo, Rio de Janeiro, Brazil registered under company number 33.748.831/0001-03, represented by Prof. Luis Antonio dos Santos Diego, President of the SBA, duly authorised,

hereinafter referred to as "SBA".

- 2) The ESAIC signs this agreement as the holder and provider of the European Diploma in Anaesthesiology and Intensive Care (EDAIC). The EDAIC is a diploma delivered after the successful completion of the EDAIC Part I examination (written) and EDAIC Part II examination (oral). EDAIC holders (DESAIC) must be specialists in the field of anaesthesiology at national level. The SBA signs this agreement as the holder and provider of the Título Superior de Anestesiologia (TSA). The TSA is a diploma delivered after the successful completion of a written examination and an oral examination. TSA holders must be specialists in the field of anaesthesiology at national level, in Brazil.
- 3) As of 1 January 2024, holders of the EDAIC can gain exemption from the TSA written examination. Equally, TSA holders can gain exemption from the EDAIC Part I examination. To gain exemption, diplomates will have to submit proof of the relevant qualification, which can be authenticated with the issuing body in case of doubts (ESAIC uses a certified platform using blockchain technology for the issuance of its diplomas).
- 4) EDAIC remains the exclusive property of ESAIC and TSA remains the exclusive property of SBA.
- 5) This agreement is for an indefinite period of time and may be terminated by either party considering a notice period of one year. Any change in the educational value (structure, contents, requirements) of either diploma will be notified to the other party immediately so that this agreement can be reconsidered in the light of the new elements.

The parties agree that the provisions of this agreement, specifically those related to item 3, shall take effect retroactively as of 1 January 2024. This retroactivity does not affect any other aspects of the relationship between the parties prior to the signing date.
